





1-Minutes.—The minutes of the meeting held on 29th December, 1953, were read and confirmed.

2—Accounts for Payment.—Accounts amounting to £842. 1s. 3d. (as per list signed by the Chairman) were passed for payment.

3-Mr. W. Grant Oliver.-The Chairman welcomed back Mr. W. Grant Oliver after his long illness.

4—Damage to New Shelter on Common.—The Surveyor reported that on three occasions in February and once in March damage had been caused to the New Shelter on the Common.

The Surveyor's report was read stating that the damage was so small it was not possible to give an estimate.

RESOLVED—That the Clerk be instructed to inform the father of the boy that in this instance his son will not be prosecuted but if this offence be repeated the Conservators would not again treat the matter so leniently.

4-Brighton Lake.—The Surveyor submitted the following letter from the Director of the Freshwater Biological Association :—

FRESHWATER BIOLOGICAL ASSOCIATION.

DEAR MR. BISHOP,

We have examined the sample of Equisetum you sent with your letter of 31st August and it does appear to be Equisetum limosum.

I think the only chemical which is likely to be effective in eradicating it is arsenic. Whether it is possible to use this substance depends of course on what happens to the outflow, if any, from the pond. I think it would also be desirable to keep people away from it for a short time after arsenic had been applied, but if the application were made in summer and the place closed to the public for a fortnight I think you need have no fear of there being any danger to humans—I doubt in fact whether there would ever be any danger but it would be as well to be on the safe side. According to a leaflet published by the American Fish and Wildlife Service sodium arsenite in concentrations up to 1.5 p.p.m. of arsenious oxide  $(As_2O_3)$  will kill most weeds except water lilies and Chara (stonewort) without injuring fish. For this purpose it is usual to apply Commercial 'sodium arsenite ' (containing 32%  $As_2O_3$ ) at a concentration of about 4 p.p.m. It is best applied by sprinkling over the surface of the water especially on the areas where the weed is growing.

If circumstances make it impossible to use arsenic I think your next best course would be to drag the plants out whole by means of a harrow. If you could get a farmer to drag a harrow with good sharp tines through the pond several times in different directions I think you should drag out most of the Equisetum. This would of course make rather a mess of the

pond temporarily, but I think you would find that the mud stirred up would very soon settle again and that no permanent damage would be suffered.

Finally I think I should add that it is hardly likely to be possible to keep a shallow pond of this sort free from rooted vegetation for any long period without doing something about it. Even if you apply arsenic and succeed in killing all the Equisetum it is likely that something else will grow in its place eventually, but I think it should be possible either by using arsenic or mechanical means to obtain a few years grace from the necessity for cutting.

I hope this information may be of use to you.

7-Elm Tree.—The Surveyor reported that there was a dead elm tree on the Common near London Road and Major York's Road which he thought should be cut down as he considered it unsafe.

8—Plaques on Seats.—The Surveyor reported a request he had received from Mrs. Dupont that a plaque in memory of a Mrs. Malkham should be placed on a seat on the Common opposite the Central Hotel, on which she frequently used to sit.

"I have made a further examination of the above tree. The tree can be examined at 5 points where branches have been removed in the past - 1 on the main trunk, 2 on each main branch and also at the main fork of the crown. In all cases there is evidence of serious rot and a chisel could be inserted to a depth of about 4 inches in one hole in the main branch overhanging Major York's Road. The whole tree leans towards the road.

In reference to minute 5, Commons Conservators, 10th April, 1956, there is no action which I could take to render the

tree safe and I suggest that the Conservators Committee should inspect this tree at the earliest possible moment. In my opinion the tree is definitely dangerous and will become more so as the weight of foliage increases.

#### Surveyor to the Conservators.

The Clerk reported that, in view of the terms of the memorandum, he had got in touch with the Chairman of the Conservators and with as many members as possible of the Committee and with their authority had advised the Surveyor that the tree should be felled.

- 2. <u>ACCOUNTS FOR PAYMENT</u>. Accounts amounting to £736. 14. 7d. were passed for payment (all as per list signed by the Chairman).
- 3. <u>WYCH ELM.</u> The Surveyor reported that the Wych Elm in Major York's Road had now been removed and that the sum of £12 had been paid to the Lord of the Manor as the value of the timber.
- 4. <u>COMMITTEE</u> CHESTNUT TREE. The following minutes of a meeting of the Committee held on the 15th August, 1956 were submitted to the Conservators.

"15th August, 1956, at a meeting of the Committee of the Conservators held at Fonthill, the Common -

Present

Messrs. R.S.R. Berry, W. Grant Oliver, S.V. Thorpe, and Councillor N.L. Glanfield.

CHESTNUT TREE - The Surveyor reported that, in his opinion, the most westerly of the three horse chestnut trees in front of the Fonthill Shelter was in a dangerous condition and submitted tenders from

(a) Mr. A. Farnes to fell the tree for the sum of £4, and

(b) Mr. F. Theobald to lop and fell the tree for the sum of £15.

<u>Resolved</u> - That the Surveyor be authorised to discuss his proposals with Mr. Farnes and to accept his tender or any reasonable modification thereof. "

The Surveyor reported that the chestnut tree referred to therein had been felled on 17th August, 1956 at a cost of £4.

5. <u>TREES</u>.- A letter was submitted from Mrs. Ellen A. White suggesting that a sapling should be planted near to the site of the recently felled chestnut tree at Fonthill and offering to defray the cost of this work.

Resolved -

- (a) That Mrs. White be thanked for her offer which the Committee regrets it is unable to accept, but that she be informed that the question of planting additional trees in the vicinity of Fonthill will be considered in conjunction with the general question of re-planting on the Common.
- (b) That the Surveyor be instructed to consider and report on the clearing of seedlings and the planting of additional trees on various parts of the Common.
- (c) That the forthcoming report of the Surveyor be referred to the Committee with power to take such action thereon as they may consider appropriate.

6. <u>BRACKEN</u>. - The Surveyor submitted a letter from the West of Scotland Agricultural College, from which the following are extracts :-

" The Secretary of the Dept. of Agriculture for Scotland passed to me your letter of the 27th August (ref. HPB/BCG: pl/4a) concerning the eradication of bracken on Tunbridge Wells Commons.

Bracken is probably our worst perennial weed in the West of Scotland and accordingly a large amount of research work on the problem has been done in this College. At present the two main practical methods of control are ploughing and mechanical treatment (i.e. cutting or bruising). The latter method is the one in most common use in Scotland as bracken occurs mainly on land which cannot be ploughed.

Ploughing has given 100% eradication in many cases and is probably the best method if the land is even, free from stones, and has a good depth of soil. After ploughing the land must be cultivated, fertilised and brought into a normal farm rotation or it can be directly re-seeded with grass, which would possibly be more suitable in your particular case. Costs for re-seeding depend on conditions but an average in our area would be from £20 to £30 per acre including fertiliser and seed.

Mechanical treatment is used where the land is unploughable. The main implement in the past was the scythe but this has been mainly superseded by tractor drawn machines either of the cutting or bruising types.

A cutting or bruising programme should be carried on over at least 3 consecutive years with two treatments per year. The time of the first treatment is particularly important and this is when the bracken fronds are almost but not completely unfolded. This stage would be reached in the south of England by early June. The second treatment should follow 6 weeks later. Cutting or bruising after 3-4 years treatment will not eradicate bracken completely but it will reduce the bracken very substantially in height, e.g. from 3-5 ft. to 6-12 inches and will keep it in check for a period of 5-8 years when a single treatment may be required. Where bracken has been cut the trampling effect by heavy stocking with cattle is effective in final eradication.

Various selective weed control chemicals have been tried but none have been found effective against bracken. Sodium chlorate which is a soil sterilant has been found effective but for economic reasons it is only of use for "mopping up" patches which could not be reached by machines. "

<u>Resolved</u> - That consideration of the matter be deferred to enable the Surveyor to report further thereon at the next meeting.

- 7. <u>INSURANCE</u>. The Treasurer reported that he had verified that the Conservators were covered in the sum of £50,000 in respect of public liability and that a fresh Fire Insurance Policy had been issued to the Conservators.
- 8. <u>LITTER BINS</u>. Referring to paragraph 11 of the minutes of the Conservators meeting of the 3rd July, the Surveyor reported that the litter bins had now been provided.

- 9. CYCLING ON THE COMMONS .- Mr. Berry and other members referred to the danger arising to members of the public through cycling occurring on the Commons and the Press were asked to call attention to the fact that this practice was an offence against the Commons Conservators! Byelaws and offenders were liable to penalties.
  - The Surveyor reported that the cost of erecting the notices referred to in paragraph 13 of the minutes of the 3rd July would amount to approximately £20 for which no provision had been made in the estimates.

Resolved - That consideration of this matter be deferred until the estimates for the next year are under consideration.

10. FENCING AROUND THE HIGHER CRICKET GROUND .- Referring to paragraph 3 of the minutes of the Conservators of 10th April, it was

Resolved - That the Surveyor be instructed to proceed with the fencing of the Higher Cricket Ground for which provision had been made in the estimates.

11. LOWER CRICKET GROUND .- It was moved and seconded that the rails removed from the Higher Cricket Ground be used to fence in the south-west corner of the Lower Cricket Ground. On being put to the meeting the motion was lost. It was

Resolved - That the rails removed from the Higher Cricket Ground be taken into store, that the question of fencing the portion of the Lower Cricket Ground be considered in conjunction with the estimates for the next financial year.

12. UPPER STREET .- Mr. Councillor Savage called attention to the danger from traffic constituted by the position of a rock adjoining Upper Street.

It was pointed out that the question did not appear to be one with which the Conservators could deal.

- 13. RACE COURSE .- Resolved That the Surveyor be requested to report on the possibility of restoring the race course on the Common.
- 14. EXPENDITURE. The Conservators discussed the desirability of specific authority being given to incur expenditure for which provision had been made in the estimates. It was

Resolved - That the Clerk be instructed report to the Conservators the action taken by the Town Council with regard to the provision of funds to enable the Conservators to consider whether to proceed with projects for which provision had been made in their estimates.

- (c) The attention of the Superintendent of Police be called to the desirability of a patrol operating on this path, particularly on a Saturday morning.

### REPORT OF THE SURVEYOR TO THE COMMONS CONSERVATORS FOR

APRIL, MAY AND JUNE, 1958.

- 1. The Brighton Lake has been cleared of rubbish and weeds (April,1958). This annual clearance appears to be gradually weakening the growth of the weeds.
- 2. Seven concrete posts have been erected along Bretland Road and in front of Baxterley Flats (Minute 4. meeting 1/4/58).
- 3. The ditches and surface water drains in the area between Lower Green Road and Rusthall High Street have been cleared to improve the drainage from neighbouring footpaths.(April/May 1958).
- 4. The paved channel across the footpath by the Brighton Lake has been widened and made slightly deeper. The channel cannot be made any deeper due to the shallowness of a pipe underneath. (minute 3. meeting 1/4/58).
- 5. Three areas on Tunbridge Wells Common have been cleared following fires in the gorse and undergrowth (April/May 1958).
- 6. Grass cutting by Allen scythe was started on 7th May,1958. The following areas have been cut: - Inner Bishops Down, Mount Ephraim, the Race Course, London Road, Nevill Park and the junction of Major Yorks Road and Hungershall Park, Church Road and Castle Road and Rusthall Road and Lower Green Road.
- 7. The small twigs growing from the lower parts of the trunks have been trimmed from lime trees (a) near Rusthall Beacon (b) at junction of Major Yorks Road and Langton Road and (c) in Eridge Road.
- 8. Following complaints that unauthorised persons were with difficulty being restrained from playing cricket on the Higher and Rusthall cricket grounds a quotation has been obtained for two notices giving appropriate extracts from the Byelaws. The notices would be printed and protected by laminated perspex and if approved, it would be suggested to the respective cricket clubs that they fix the notices externally on their pavilions.

The quotation for the two notices is  $\pounds 6.16.0$ . and the byelaws to be reproduced are Nos.21,22,24 and 25.

9 Attention has been drawn to "suckers" from the parent wild cherry stock growing tinktworof the ornamental Cherry Trees in Mount Edgembe Road. These growths will be removed in the late Autumn.

PRESENT : Messrs. R.S.R.Berry, H.Clarke, R.F.Gunnis, S.V.Thorpe and Councillor N.L.Glanfield

The committee considered the following report from the Surveyor to the Conservators :-

Large Oak Tree between London and London Inner Roads near Rose Hill School.

Attention having been drawn to the condition of the above tree, it was decided in the interests of public safety, that it should be roped off and warning notices erected.

A very large crack has developed in the Northern portion of the tree. It is evident that this crack has been developing for a long time but there are also signs that it has recently become worse. I consider that the tree should be regarded as immediately dangerous and after considering other methods of treatment I recommend that it should be felled.

Other possibilities would be (a) to endeavour to make it safe by strapping with metal bands and anchorages to the remaining part of the tree and (b) to lop and top the tree in order to relieve the weight on the defective portion.

In the former case I think a lot of money could be spent to no avail, as the sound part of the tree would not provide a safe anchorage for the defective part.

With regard to the second possibility I think the amount of lopping and topping required to make the tree safe would destroy its amenity value and that the amount of cutting would lead to the rapid deterioration of the tree.

In the event of a decision that the tree should be felled it might be thought desirable to plant one or more Oak trees to provide future replacements.

Dear Sir,

By arrangement with Mr.Couchman I examined, with him and Mr. Farr, on September 10th a large storm damaged Oak growing on the margin of Tunbridge Wells Common, near the London Road.

The tree is probably 200 or more years of age and it has for many years been an excellent example of the Oak as an Ornamental Tree. From a distance it might still be regarded as being in good health but close examination reveals that it is suffering severely from storm damage and is now in a very dangerous condition.

Unnoticed, deterioration of the tree must have been going on for a long time as much of the heart wood is suffering from decay, making the thin margin of living sap wood unable to support the branch system.

The rather short trunk divides into two very large and heavy branches, one of which has developed long, open cracks on two sides, perhaps from twisting wind action. However the cracks came about they make the branch very dangerous, a condition that should be given prompt attention.

Two means of dealing with the dangerous state of the tree are available, One, the removal of the greater part of the branch system, cleaning out decayed wood pockets, bracing weak places, treating exposed wood with a preservative substance, filling cavities with cement to exclude water, and any other protective work that may develop. The other method is to cut down the tree and replace it with a young one.

Repair work would be expensive and the necessary mutilation of the branch system would make the tree very ugly. The cracked branch would have to be removed to the base, and the opposite branch would have to be well shortened and all wounds properly treated. Therefore, it would be better to dispose of the tree than to save it at some expense as a badly crippled object. If repaired it should be given periodical examination.

Repair work on trees is a specialised occupation. I do not know of any reliable person in the neighbourhood who undertakes the work but a firm that advertises in professional journals is The Southern Tree Surgery Coompany, Byways, Woodham Lock, West Byfleet, Surrey. I have not seen any of the firm's work, but it is bound to be expensive.

Should your Conservators decide to remove the tree I advise grubbing it up by the roots rather than sawing it off just above the grass. In the position a sawn off butt would probably be a menace to mowing machines.

- 5. The two Notice Boards relating to the playing of games on The Higher and Rusthall Cricket Grounds were fixed on 13th August, 1958, as approved by the Conservators at the last meeting.
- 6. It is proposed to clear a further section of the old Race Track during the coming Winter, probably on the north side of Hungershall Park.

#### Report of the Surveyor to the Commons Conservators for December Quarter, 1958.

- 1. <u>Old Race Track</u>. The clearance of the old race track has now been completed. The portions recently completed are those between Hungershall Park and Major Yorks Road and Major Yorks Road to Fir Tree Road.
- 2. <u>Clearance of Undergrowth</u>. In accordance with the approved plan the clearance of undergrowth has commenced on Sections 5 and 31 and Section 4 will be dealt with should time permit.
- 3. <u>Planting of Young Trees</u>. Also in accordance with the approved scheme young oak trees have been planted in Sections 2, 3 and 31. It has been possible to salvage a number of wrought iron tree guards from well established trees on the Common and they have been used to protect the most exposed of the newly planted trees.
- 4. <u>Dangerous Tree near London Road</u>. This tree has been felled and grubbed and the surface of the Common temporarily made good. Grass seed will be sown on the bare patch in the Spring should it appear necessary.
- 5. <u>Old Oak Tree opposite Tweeddale Terrace</u>. The undergrowth around this tree has been cleared and although a surrounding railing indicates that the tree had some special significance no plaque has been found to indicate the reason why, and the date when it was planted. Although the tree is very old there is no indication that it is dangerous and it is suggested that it should be left in its present condition until such time as felling becomes imperative.
- 6. <u>Rusthall Cricket Ground</u>. In accordance with the approved request by the Rusthall Cricket Club a clearance of undergrowth has been made in the vicinity of the Pavilion.
- 7. <u>Lower Green Road, Rusthall</u>. In accordance with recent practice a strip of undergrowth has been cleared on either side of this road between Rusthall Road and Langton Road.
- 8. Lower Cricket Ground. It is suggested that consideration be given to the removal of the remaining posts around the Lower Cricket Ground as they no longer serve any useful purpose in the absence of railing. Many of the posts are broken and constitute some danger to the general public. An exception could be made by the retention of posts at the junction of Church Road and London Road and the junction of Castle Road and Mount Edgecumbe Road.

Thorpe; they appreciated the thoroughness with which for over forty years he discharged his duties as a Conservator and will miss the benefit of his unrivalled knowledge of the Manor of Rusthall so readily placed at their disposal.

(b) That the Clerk be instructed to convey to Mrs. Thorpe and her son the sincere sympathy of the Conservators in their bereavement.

(c) The Clerk submitted a letter from Mr. Leslie J.D. Bunker, intimating that the Pord of the Manor desired to nominate as a fourth representative Mrs. Griselda Katharine Kentner of 1 Mallord Street, Chelsea, S.W.3.

4. BAXTERLEY DUSTBINS.- The Conservators considered a further letter from Mr. J. M.S. Bright complaining that 4 dustbins were still standing on the Common outside Baxterley.

> The Clerk reported that he had interviewed the owner of these flats who had in consequence of the request of the Conservators, already instructed his Agents to deal with this matter, but that the dustbins were still in position this morning. The owners had promised to supply the Clerk with the names of the individual tenants of the flats.

Resolved - That when the Clerk receives the names of the tenants he write to them calling their attention to the infringement of the Commons Byelaws and requesting them to remove the bins.

5. GAMES ON THE COMMONS.- (1) The Conservators considered a letter from Mr. A. G. Deane complaining of the playing of football on that portion of the Common lying between Rusthall Church and Rusthall Beacon, suggesting that such games might be transferred to the other side of Langton Road.

> Resolved - That the Clerk be instructed to inform Mr. Deane that the Conservators deprecated the use of the Cricket Ground for the playing of football, and that no offence against the Conservators' byelaws appears to have been committed by the youths playing football.

(2) Mr. Berry drew attention to the fact that on Easter Monday a coach load of people apparently from London, had spent a considerable time playing games on the Upper Cricket Ground being a portion of the Common set apart for cricket. 29

Resolved - That should members of the Conservators notice the repetition of a similar occurrence they be requested to make a note of the name of the Coach Proprietor and notify the Clerk.

6. TREES ON THE COMMONS.- The Conservators considered a letter from J. Rawson and Sons Limited calling attention to trees in the vicinity of their garage in London Road which were detrimental to their building.

The Surveyor reported that the trees in question might in fact be a danger to the Company's buildings and were in any event unsightly.

Resolved - That the Surveyor be instructed to remove the trees in question.

7. PATHS AND SEATS ON THE COMMON.- The Conservators considered a letter from Mrs. Robinson of the Vale Royal Hotel asking the Conservators

> (a) To repair the paths in the vicinity of the Lower Cricket Ground

(b) To replace the existing seat on the path from Stevensons Garage to the Vale Royal Hotel and to provide additional seats near this path opposite the Castle Hotel. She also suggested that some of the seats in Queens Grove might be transferred to more open situations.

The Surveyor reported that he had already commenced to repair the paths referred to.

Resolved - (1) That the existing seat on the path from Stevensons Garage towards the Vale Royal Hotel be moved to a point closer to the path and that an additional seat near this path be provided.

(2) That the question of reducing the number of seats in Queens Grove be considered when the question of providing seats on other parts of the Common arises.

8. CARS PARKED ON THE COMMONS - The Conservators considered a letter from / Mr. E. MacDonald of 17 Apsley Street complaining of cars being parked on the Common.

Resolved - That the matter be referred to the Commons Ranger in the first instance and that it be further considered at the next meeting of the Conservators.

- 9. SURVEYORS REPORT (1) TREES LONDON ROAD Mr. Councillor Glanfield called attention to the fact that the trunks of trees felled in London Road were still lying on the Common and suggested that steps should be taken to have them removed. The Representatives of the Lord of the Manor stated that they had been unable to sell the timber but were prepared to permit the Surveyor to dispose of it to any contractor who would undertake to remove the trunks.
- 10. BRIGHTON LAKE. Mr. Councillor Savage enquired whether any progress was being made with the clearing of Brighton Lake. The Surveyor reported that the condition of the lake was gradually being improved and he hoped that in the course of time the weed would be entirely cleared.

11. TIME OF MEETINGS - Resolved - That future meetings of the Conservators

be held at 2.30 p.m. and that minute 9 of January 5th 1959 be varied accordingly.

### REPORT OF THE SURVEYOR TO THE COMMONS CONSERVATORS FOR MARCH QUARTER 1959.

### 1. <u>Clearance of Undergrowth</u>.

The clearance of undergrowth in accordance with the approved plan has been completed on Sections 4, 5 and 31. In the main the policy has been to clear a strip of bramble and other growth along each side of the roads and main footpaths crossing these sections leaving the undergrowth beyond the strip untouched to provide cover for birds and small animal life. At the same time mishapen or damaged underwood has been cleared from the strips in order to improve the appearance of the more shapely trees and underwood.

### 2. <u>Trees - London Road</u>.

In accordance with the Conservators' instruction, 2 Oak trees and 2 Beech trees, obtained from Messrs. Arthur Charlton, have been planted on the open ground between London Road and London Inner Road on the South side of Church Road.

#### 3. Lower Cricket Ground.

The work of removing the defective posts and reinstating the posts at the junction of Church Road and London Road and of Castle Road and Mount Edgcumbe Road is in hand and will be completed by the end of the month.

#### 4. Bretland Road - Baxterley Flats.

In accordance with the Conservators' instructions 2 additional posts have been provided in front of the Baxterley Flats. One of the original posts has been broken by a coal lorry and will be replaced at the expense of the owner of the lorry.

#### 5. Seat near the Spa Hotel.

Mrs. Stone has confirmed her offer to pay for the provision of a seat to be erected near the 'bus stop outside the Spa Hotel. The necessary seat is on order and will be fixed in a position tentatively agreed with the late Mr. Thorpe.

### 6. Trees near Stevensons Garage.

In accordance with the instructions of the Conservators the above have now been inspected. There are 2 small Oak trees and 1 small clump of Sycamore growth. The Sycamore growth is nearest to London Road and in my opinion this growth and the 2 small Oak trees form a screen to the end of the garage building and it would be a loss to the amenity if any of them were removed. No complaint has been received from Messrs. Stevensons but it is conceivable that in due course, when they become larger, the 2 Oak trees will become a nuisance to the garage and the roots a potential danger to the structure.

### 7. Hungershall Park.

The practice of parking on the South side of Hungershall Park has developed recently and has caused damage to the Common and has been the subject of complaint by members of the public, and as an experiment small banks of soil have been formed across the 2 openings. When these have consolidated it is proposed to cover them with turf.

BYELAW framed by the Conservators of the Tunbridge Wells. Commons under the Tunbridge Wells Improvement Act, 1890, for the government, control, improvement and management of the said Commons.

BYELAW No. 23 of the Byelaws framed by the Conservators of the Tunbridge Wells Commons on the 26th day of May, 1891, and confirmed by the Secretary of State on the 23rd day of February 1892 is hereby repealed.

- (2) That the Clerk be instructed to apply to the Secretary of State for confirmation of the Byelaw and to give notice of intention to apply for such confirmation.
- 4. <u>CARS PARKED ON THE COMMONS.</u> Referring to minute 11 of the meeting of 30th June, 1959, Mr. Card reported that the Commons Ranger had investigated complaints of parking on the Commons and found that the complaint really concerned noise made by engines of cars which were frequently driven on to the Commons very late at night.

<u>Resolved</u> - That no further action be taken in this matter for the time being.

- 5. <u>SURVEYORS REPORT</u> .- (1) WHILIGH OAK <u>Resolved</u> That the thanks of the Conservators be conveyed to Mr. Marshall for his generous offer, but that it be not accepted.
  - (2) TREE NEAR LINDEN PARK CRICKET GROUND The Surveyor reported that he had received a request from the Secretary of the Linden Park Cricket Club that an oak tree on the south side of the Crick Ground which had not been lopped at the same time as adjoining

trees, should now be dealt with.

<u>Resolved</u> - That the Surveyor be instructed to lop the tree in question.

6. "THE BUMPS". - The Surveyor reported that a piece of ground known as "The Bumps" in the vicinity of Harmony Street, Rusthall, had been cleared some time ago and that in an attempt to attract footballers from the vicinity of the Happy Valley, it might h desirable to erect goal posts which could be provided from trees now growing on the Common.

The Lady of the Manor intimated that she had no objection to the Conservators felling trees for this purpose.

<u>Resolved</u> - That the Surveyor be authorised to carry out the work.

7. <u>CONDITION OF THE COMMONS</u> - (1) The Conservators considered a letter fro Mrs. Brame Hildyard calling attention to the trees overhangi the footpath running from the Langton Road: to the conditio of the seat adjoining that footpath and the overgrown state the Common in that vicinity.

> The Surveyor reported that the trees referred to wer growing on private property: that the seat was in fact not suitably placed, and required renewing and that the undergro would be dealt with in the ordinary course of the routine wo on the Commons.

> <u>Resolved</u> - That the Surveyor be instructed to erect a new se in the vicinity, but that it be resited.

(2) Mr. Berry then called attention to a complaint in the local Press that Rusthall Common had been neglected.

The Surveyor reported that this complaint was without foundation as the Rusthall Commons received equal treatment to the Tunbridge Wells Common.

8. NOTICES ON THE COMMONS. - Mr. Card reported that the Lord of the Manor was desirous of erecting notices on the Commons prohibiting cycling on certain footpaths. It was pointed out that such notices would be ineffective for the purpose of prosecution under Byelaw 32 of the Conservators Byelaws. Mr. Card the offered to present the notices to the Conservators, provided that their erection was authorised.

> <u>Resolved</u> - That the Conservators authorise the erection on the Common at points near the Wellington Rocks, the Upper Cricket Ground and the Lower Cricket Ground respectively of notices prohibiting the riding of cycles on the footpaths on the Commons.

9. CAR PARKING. Mr. Card also reported that the Lord of the Manor wished erect on the Commons notices prohibiting the parking of mot vehicles there except on payment of a fee of 1/-. The Conservators expressed concern that such notices might encourage motorists to use the Common as a parking place to the detriment of the Commons. Attention was also called to Byelaw No.32 which prohibits the driving of vehicles on cer portions of the Commons.

> <u>Resolved</u> - That consideration of this matter be deferred to enable the Clerk to discuss the subject with a representation of the Lord of the Manor.

10. STOPPAGE OF DRAIN LEADING TO MOUNT EPHRAIM SHADES - The Clerk submitted a letter from Messrs. Berry and Berry claiming that the stoppage of a drain leading from the Mount Ephraim Shades to the sewer in Mount Ephraim had been caused by the roots of willow trees growing on the Common.

> The Clerk reported that this claim was being dealt with by the Conservators' Insurers.

# to the Commons Conservators for October Quarter 1959.

#### 1. Grass Cutting.

The normal programme of grass cutting has proceeded. The area in the vicinity of Bishops Down and Mount Ephraim having received a second cut and additional cutting having been carried out in the vicinity of Font Hill, London Road. Various areas where fires have occurred are being cleared.

#### 2. <u>Weed Spraying</u>.

Some experimental work has been done on weeds near St. Helena, London Road and in other places and the effect is being watched. The spraying was done rather late in the season for best results and it may be that the rapid evaporation due to the very hot weather will have lessened its effect.

#### 3. <u>Removal of Trees</u>.

In accordance with the Conservators' instructions, quotations were invited from three contractors for the removal of the trees near Rosehill School, Messrs. Rawson's garage, Montacute Gardens and Lower Green Road, Rusthall. Only one quotation, that of Mr. Theobald, was received and following consultation with the Mayor and Chairman of the previous meeting, his quotation of £18 was accepted and the trees have now been removed. This amount was approximately £5 in excess of the amount in the Suspense Account but it is anticipated that the balance can be provided out of General Maintenance.

### 4. Brighton Lake.

A limited area of the lake has been cleared of weed in order to compare the effect of removing the weed late in the season instead of in the Spring as has been the practice up to date. Observation will be kept to know if there is any advantage in leaving the work of clearance until the late Summer.

#### 5. Whiligh Oak.

The small wooden palisade around this oak tree which was planted near the Spa Hotel in 1954 had become rotten and was recently removed. Subsequently a Mr. Clifford Marshall (a Member of the "Men of the Trees") offered, through Mrs. Clemetson, to pay for the provision of a new guard. Actually a wrought iron guard was salvaged from a tree on the Common not now needing protection and has been placed round the tree. Mrs. Clemetson has also handed to me a metal plaque commemorating the planting of the tree which has never been fixed in position because of the risk of damage to the plaque. It seems desirable that the plaque should be placed in position and probably the best safeguard would be to embed it in a dwarf concrete pillar, to be let into the ground near the foot of the tree. The cost of providing the salvaged tree guard and erecting the plaque would amount to about £2. The Conservators instructions are required as to whether Mr. Marshall's offer should be accepted or whether the work should be paid for out of General Maintenance.

#### 6. <u>Wooden Railings - Mount Ephraim</u>.

The dwarf wooden railing, along the top of the bank near the junction of Mount Ephraim and London Road was recently damaged by a car. The driver of the car has been contacted for an assurance that she will pay for the cost of repair. Two other rails had to be removed as they had been damaged by unidentified persons and were likely to be a danger to passers-by.

#### 7. <u>Happy Valley</u>.

During the Autumn it is proposed to carry out repairs to the steps leading down the Valley.

#### 8. <u>Clearance of Undergrowth, etc</u>.

During the coming Winter it is suggested that the programme for clearing undergrowth should include a strip along the South Western side of Major Yorks Road as recently complaints were received that damage was being caused to double-decker 'buses by overhanging branches. The clearance of a strip along this road would eliminate the risk of damage and it is felt would improve the appearance of the Common along the road frontage.

Royal Mount Ephraim Hotel.

We act for Mr. J.C. Daeppen, the owner of the above property, who informs us that about a week or a little more ago it was discovered that there was a stoppage in the drain leading from the building known as "The Shades".

This drain has now been examined and excavation made up to the point where it joints the main sewer. It has been found that the blockage has been caused by tree roots, believed to be elm, which have grown into the sewer and have completely stopped up the branch leading to the Mount Ephraim Shades. The roots have been sent for analysis to confirm that they are in fact elm. According to our instructions, the only elms in the immediate vicinity are those on the opposite side of the road growing on the common and it is thought that the roots of one of these have penetrated the sewer and caused the trouble that has arisen. The drain is now open and can be examined if desired and will remain open for another few days before the repairs can be completed.

Should the roots prove to be of elm origin, we anticipate that Mr. Daeppen will give us instructions to make a claim against the Conservators for trespass in allowing the roots to spread unchecked. So far as we can see, this is solely a matter for the Conservators and not a concern of the Lord of the Manor because by the Tunbridge Wells Improvement Act 1890 management of the commons, and in particular the trees, was taken away from the Lord of the Manor and vested in the Commons Conservators.

Our object in writing to you at this stage is to afford you the opportunity of instructing a Surveyor to inspect the pipe so that he is able to see the circumstances from which the conclusions are drawn. You may, however, think it unnecessary to arrange for such an inspection because the drain and the cause of blockage have, we understand, already been examined by a member of the Borough Surveyor's department. Further, we believe that there is a third party indemnity policy affecting the commons and the liability of the Commons Conservators and it may be you would think fit to communicate the possible claim to the insurers.

- PRESENT The Mayor (Councillor N. L. Glanfield J.P.)Chairman Mrs. G. K. Kentner Messrs. G.R. Barr, R.S.R. Berry, R.W. Card, A.S. Maddams, C. Wood. Councillor Savage.
- 1. <u>MINUTES.-</u> The minutes of the last meeting were read and confirmed.
- 2. <u>ACCOUNTS. Accounts amounting to £731.14.2d.</u> were passed for payment (as per list signed by the Chairman).
- 3. <u>MEMBERSHIP</u>. The Clerk reported that since the last meeting of the Conservators, Admiral Sir Cecil Harcourt, C.B.E., K.C.B., K.B.E., had died leaving a vacancy on the Conservators for a representative of the Lord of the Manor.

It was resolved - That the Conservators place on record the sense of their loss through the death of Admiral Sir Cecil Harcourt and their sympathy with the Ladies of the Manor.

- The Clerk reported that the Ladies of the Manor had appointed Mr. Cyril Wood of 7 London Road, Tunbridge Wells to fill the vacancy caused by the death of Sir Cecil Harcourt.
- 4. <u>REPRINTING OF BYELAWS</u>. The Clerk reported that the supply of copies of extracts from the Tunbridge Wells Improvement Act, 1890, and the Conservators<sup>°</sup> Byelaws was nearly exhausted and that it would cost approximately £36 to reprint 100 copies or approximately £12 for the same number of copies to be reproduced by the Multilith process.

<u>Resolved</u> - That 150 copies of the Extracts from the Tunbridge Wells Improvement Act, 1890, and the Byelaws be printed and the sum of  $\pounds45$  be added to the estimates for this purpose.

5. <u>ESTIMATES</u>. - Estimates of the amount required for the purposes of the Commons Conservators for the next financial year amounting to £3,002 were approved.

<u>Resolved</u> - That the Finance Committee of the Corporation be requested to make provision in its Estimates for the next financial year of an amount of  $\pounds 3,002$  under the provisions of the Tunbridge Wells Improvement Act, 1890, and Section 164 of the Public Health Act, 1875.

6. <u>BRIGHTON LAKE</u>. - Mr. Councillor Savage called attention to the desirability of providing thick woollen stockings for the men wearing waders when cleaning out Brighton Lake.

The Surveyor reported that this provision would be made in the future.

- 7. <u>BYELAWS</u> OBJECTIONS. The Clerk reported that the proposal to repeal Byelaw No. 23 had been duly advertised and that a number of objections had been received all on the grounds that "the legalisation of Sunday Games would detract from the value of Sunday as a day of rest and worship and would open the way for further and more extensive activities." The Clerk reported that the Home Office had invited the observations of the Conservators on the objections and was instructed as to the reply.
  - 8. <u>CONDITION OF THE COMMONS</u> (1) The Conservators considered a further letter from Mrs. Brame-Hillyard concerning the removal of a tree adjacent to a footpath running from Langton Road.
    - The Surveyor reported that one branch of the tree might cause an obstruction.

<u>Resolved</u> - That the Surveyor be instructed to remove the branch in question.

- (2) Mr. Higgs, the owner of Romanoff Lodge, had asked for the removal, at his expense, of certain thorn trees close to his house.
- The Surveyor reported that there was no objection to Mr. Higgs<sup>°</sup> proposal which would, in fact, improve the prospect.

<u>Resolved</u> - That the tree in question be removed at the expense of Mr. Higgs.

- (3) Mr. Whitmore, the Hon.Secretary of Rusthall Cricket Club had requested the clearance of undergrowth near the Club's pavilion because of the risk of fire.
- The Surveyor reported that the undergrowth in question had been removed and that the clearance of the undergrowth would in future be dealt with in the routine maintenance of the Commons.
- 9. <u>22 RUSTHALL ROAD.</u> The Surveyor reported that he understood permission had been granted by the Lord of the Manor to the owner or occupier of 22 Rusthall Road to make a vehicular access across the Common from Rusthall Road to those premises; that the road had not been paved and had become founderous and that drivers of vehicles were deviating on to adjoining portions of the Common.
  - The Agents to the Lord of the Manor reported that in fact no licence had actually been granted to make this vehicular access, but that negotiations had taken place.

<u>Resolved</u> - That the matter be referred to the Agent to the Ladies of the Manor.

10. CAR PARKING ON THE COMMONS. - The Clerk reported that he had discussed with Mr. Card the question of erecting notices On the Common prohibiting the parking of motor vehicles except on payment of a fee of 1/-; that under the Byelaws

made in 1863, the standing of vehicles on any part of the Commons had been authorised but that in his view the Byelaws had since been overridden. Having regard to the saving clause in the Tunbridge Wells Improvement Act of 1890, it was open to the Lord of the Manor to authorise the standing of vehicles on the Commons to the extent that he and the Freehold Tenants had enjoyed this right prior to the passing of the 1890 Act, and that so far as the Conservators were concerned, they could take no action to prohibit this practice. Mr. Card explained that the object of the Ladies of the Manor was to authorise the Commons Ranger to exercise discretion with regard to the parking of vehicles, and to give him authority to prohibit such parking, if thought desirable, and that in the first instance they had contemplated erecting notices on the strip of common land in Eridge Road regularly used for parking during the Agricultural Show, and also near the Fairground.

The Conservators agreed to keep the matter under observation.

- 11. ROAD LEADING TO RUSTHALL CHURCH .- The Conservators gave consideration to the condition of this road.
  - The Surveyor reported that the paths on either side of the road were maintained by the Corporation, but that for thirty years no expenditure had been incurred on the road, either by the Corporation or the Conservators but that such repairs as had been executed had been done by the Verger of St. Pauls Church. Mr. Berry stated that the Church Authorities were desirous of repairing the road and of improving the turning point at the end adjoining the Church.

Resolved - That no action be taken in this matter.

#### 12. SURVEYOR'S REPORT .-

(1) "The Bumps", Rusthall Common. - The Surveyor reported that two seats were available and suggested that they might be placed in the vicinity of "The Bumps".

Resolved - That the Surveyor's suggestion be accepted.

(2) London Road - Oak Tree - The Surveyor reported that one of the oak trees planted last year between London Road and London Inner Road had died and suggested that the small oak tree growing within 6 ft. of London Road should be transplanted. His Worship the Mayor offered to present to the Conservators a new oak tree to avoid transplanting the existing tree.

<u>Resolved</u> - That the Mayor's offer be accepted with thanks.

13. DATES OF FUTURE MEETINGS .- That meetings of the Commons Conservators be held at 2.30 p.m. on the following Tuesdays:-

#### to the Commons Conservators for December Quarter 1959.

#### 1. Whiligh Oak.

The plaque concerning this tree has now been bedded in a dwarf granite pillar which has been placed in the ground at the foot of the tree.

#### 2. "The Bumps", Rusthall Common.

This area has now been cleared and four posts have been erected to serve as goal posts.

#### Footpath - Nevill Park to Rusthall Church. 3.

The old defective seat has now been replaced in a slightly different position by a new seat.

#### Happy Valley Steps. 4.

The steps leading down the Valley have now been repaired using old stone kerb and the undergrowth at each side of the steps has been cleared.

#### 5. Footpath - Rusthall Elms to Rusthall Road.

The existing path has been restored to it's original width and has been extensively repaired with old road stone.

#### 6. Storm Damage.

Following recent storm damage it was necessary to take down one middle-sized oak tree that was extensively damaged and to lop the branches of another oak tree. Both these trees were on Tunbridge Wells Common just south of the Higher Cricket Ground.

#### 7. London Road - Oak Tree.

One of the oak trees planted last year on the Common between London Road and London Inner Road has died, probably due to the very dry summer. There is a small oak tree growing within about six feet of the London Road on the same portion of the Common which will shortly have to be trimmed because of it's proximity to the main road. It is suggested that this tree should be removed and re-planted in place of the dead tree.

#### 8. Major York's Road.

The clearance of the undergrowth on the south western side is now well in hand and on completion it is suggested that a small strip should be cleared along the north eastern side.

#### Rusthall Road. 9.

It is suggested that some clearance of undergrowth and scrub should be undertaken along the north eastern side between Langton Road and Bretland Road. This would achieve two purposes.

- (a) It would improve the very fine view from this road in the direction of Culverden and Southborough, and
- (b) It would remove some trees and bushes damaged during a recent fire.

#### GRAVEL PATH

The existing path from the end of York Road crossing the Common to Church Road near the Lever Cricket Ground has been reshaped and re-gravelled.

#### LONDON ROAD - OAK TREE

The oak tree provided by the Mayor as a replacement for the oak tree near Rose Hill School has now been planted.

#### MAJOR YORK'S ROAD.

The clearance of the undergrowth on the south-western side has now been completed and a number of small seedling birch, beech, oak and holly trees have been planted in the open spaces.

#### LANGTON ROAD - RUSTHALL COMMON

The undergrowth has now been cleared from the area on the south side of Langton Road from the entrance to Rusthall Place to the road leading to Rusthall Church and the planting of a few seedling trees is in hand.

- 3.<u>ACCOUNTS FOR THE YEAR ENDED 31st MARCH,1960</u>. The Treasurer submitted the accounts for the year ended 31st March 1960, and reported that these Accounts had been audited.

Gunnis be appointed a Committee for the ensuing year (three to form a quorum) to report to the Conservators on such matters as may be referred to them from time to time and to deal with matters of urgency which may arise.
- 6.<u>APPOINTMENT OF AUDITORS</u>.- <u>Resolved</u> That Mr. R.F. Gunnis and Mr. A.S.T. Maddams be appointed as Auditors of the Accounts of the Conservators for the current financial year.
- 7. <u>PARKING ON THE COMMONS</u> (1) The Clerk reported that as instructed by the Conservators he had discussed with Supt.Sly the problem of the unauthorised parking of vehicles on the Common and in particular on that part of the Common near Toad Rock. He had also called attention to overnight parking on the strip of land opposite Rose Hill School. He had informed Supt. Sly that the Lord of the Manor was authorising parking on certain sections of the Common but that in every such case an official receipt was issued and that in no circumstances was overnight parking being authorised. Attention had been called to the byelaws which made it an offence to drive any vehicles over the Common.
  - Supt.Sly had said that he would make a note of the points the Clerk had raised and would take such steps as he reasonably could to deal with offenders.
  - (2) The Clerk read a letter from Mr. Glyn Morgan reiterating his plea for the prevention of the use by vehicles of the unmade portion of Upper Street. He also read a letter from six other persons who

had resided in Upper St. for a great many years deprecating any interference with the access to the unmade portion of that street.

<u>Resolved</u> (1) That the Clerk be instructed to write to the correspondents and to inform them that the Conservators had given careful consideration to the arguments adduced by each side but are satisfied that the balance of convenience lies in favour of permitting the use of the unmade portion of Upper Street by vehicles legitimately required to approach the houses abutting onto that portion of the street.

(2) That the Clerk be instructed to ask the Police to prevent the parking of vehicles on the small triangular piece of grass contiguous to the unmade portion of the street.

- (3) The Clerk submitted a further letter from Mrs. MacDonald complaining of the parking of a vehicle opposite her house inApsley Street and giving information as to ownership and the Clerk was instructed to communicate with the owner of the car in question requiring the discontinuance of the practice of parking on the Common.
- 8. TREES ON THE COMMON The Clerk submitted a letter from Mr. A.D. Bush calling attention to trees adjacent to Mount Ephraim Hotel. The Surveyor reported that two of the trees in question were within the curtilage of the hotel and that until the foliage was off the trees he was unable to give an opinion as to whether the other trees were dangerous.

<u>Resolved</u> – That the Clerk be instructed to inform Mr. Bush that the Conservators have no responsibility with regard to the trees growing within the curtilage of his premises and that they will give attention to the other two trees which he mentions so soon as a thorough inspection can be made.

9.<u>RUSTHALL ELMS</u>. - The Surveyor reported the receipt of a request from Miss M.A. Johnson of Rusthall Elms that overhanging growth on either side of the road leading from Langton Road to Rusthall Elms should be cut back and that in his opinion the request was reasonable.

<u>Resolved</u> – That the Surveyor be instructed to cut back the overhanging growth

10. PATH LEADING TO RUSTHALL CHURCH. - The Clerk submitted a letter from Mrs. Brame Hillyard thanking the Conservators for cutting back brane overhanging the path to Rusthall Church and suggesting that the grass adjoining the path should be cut down.

The Surveyor reported that the responsibility for the maintena of the path in question rested upon the Tunbridge Wells Corporation and that the grass had already been cut.

II. STOPPAGE OF DRAIN LEADING TO MOUNT EPHRAIM SHADES - The

Clerk reported that this matter had now been settled by the Conservators' Insurers.

The Sycamore tree has now been removed and in due course will be replaced by a flowering thorn in agreement with and at the expense of Mr. B.H. Fountain.

#### HILIGH OAK

The young tree planted by the Men of Trees has been extensively damaged by hooligans to the extent that all shoots and the head were completely broken. The young tree has been pruned and further shoots have grown and it is hoped that with further care and attention it will recover and eventually grow into a satisfactory tree.

#### ABBITS

Following a report that rabbits had been seen in the neighbourhood of Mount Edgcumbe the Rodent Operator was called in and although only one warren was discovered this was treated with poison. It could be possible that the rabbits are lying in the undergrowth and if so it is difficult to deal with them. However no further complaints have been received since the above action was taken.

#### ALE ROLD -- POSTS AND CHAINS

In accordance with the instructions of the Conservators, enquiries have been made concerning the provision of post and chain fencing on either side of the slip road between Vale Road and London Road. #### ance of Undergrowth

Clearance of undergrowth and deformed underwood has commenced in Hungershall lark in accordance with the improved programme.

#### l Paths

A number of gravel paths have been 'edged and regraded' with a view to minor repairs with gravel and old stone when labour is available.

#### at Mount Edgcumbe

In accordance with Minute 8 of the Commons Conservators meeting 26 July 1960, the two Lime Trees standing on the Common have now been inspected. These trees are approximately 50-60 feet high and have been previously lopped and topped. In both instances there is clear evidence of considerable decay at the base of the trees and I think they should be regarded as potentially dangerous. Inspection was made from the ground, but it is apparent that decay has set in in the trees where large anches have been severed. Because of the lopping and topping, a very bushy

growth has developed at the top of the trees which must provide considerable leverage during times of storm when the trees are in full leaf. On these grounds I recommend that these two trees should be felled.

#### n Trees

Following a report in the Kent & Sussex Courier that Fire Blight had been reported by a Ministry of Agriculture Inspector in Thorn Trees on Rusthall Common, enquiries were made from the Ministry of Agriculture. In their reply they stated that an inspection had taken place but no evidence of infection had been found and that they were proposing to carry out further inspection next Spring.

#### iouain Tree

I have been concerned for sometime with the condition of the Hornbeam Tree on the triangle of grass at the junction of Major York's Road and Nevill Park, and asked the Ministry of Agriculture's Inspector to examine it. He reports that some dying back of the branches is taking place but cannot at present diagnose the cause and again proposes to examine the tree in the Spring.

Various seats have been repaired or replaced and a report on all the seats on the Common has been prepared and a schedule of the seats is attached to this Report.

#### ss Cutting

This was continued longer than usual due to loss of time through bad weather and to the late growth of grass in a mild Autumn.

#### lter and Tool Hut

Attempts are being made to waterproof the men's shelter and tool hut under the bank near the Higher Cricket Ground.

#### ches

During the exceptional rainfall particular attention was paid to clearing ditches alongside footpaths and drives.

#### Existing Seats

The existing seats may be divided into the following classifications:-

#### 1. Concrete ends with oak seats and backs : 95

These are relatively new, are in good condition and form just over one third of the total.

2. Concrete ends with oak seats only :

These are quite new and are in good condition. They are not particularly suited to the Commons and were supplied when no other types were available. They were designed for use in very restricted positions in streets.

3. Oak ends with oak seats and backs :

These were probably the original seats installed on the Commons and have proved suitable and durable. With the rising costs of timber and labour they have been replaced by those in classification 1. above. Apart from normal decay the backs are prone to damage by irresponsible persons. More than a quarter of these seats have the back missing. Because of the cost and difficulty of fixing new backs it has been the practice to saw off the damaged backs and utilise the seat until complete renewal becomes necessary.

4. Oak ends with oak seats cnly :

Similar to classification 3. but without the back and used only around the perimeter of the Higher Cricket Ground. Neat and unobtrusive they are very suitable for this exposed position.

5. Iron ends with oak seats and backs :

A very simple and durable form of seat, but not as attractive as those in classification 3.

6. Iron seats with backs :

These may have been presented to mark-send special occasion or in memory of a particular person.

7. Teak seats with backs :

Apart from a single seat near the Higher Cricket Ground inscribed "Percy Wickenden" these are sited along the 'South of France' and by the group of trees near the junction of Mount Ephraim and Church Road. Superior in material, design and workmanship they have probably been selected for their special situations.

NOTE :

The total number of seats is 273, distributed thus :-

Tunbridge Wells Common : 221 Rusthall Common : 52.

Compared with the record of seats made in 1953 a total of 8 have been removed and not replaced.

# eneral Condition of existing seats

Of the total of 273 seats 242 may be said to be in reasonably sound or etter condition. In a few cases the ends need adjusting in order to raise the eats or to make them level and these will be dealt with by the general maintenance aployees. A few of the 242 need some structural repairs of a minor nature.

The remaining 31 are in poor condition and need major repairs or mplete renewal.

In addition to the normal requirements of a seat it is essential that hose on the Commons should be :-

To fulfill these requirements it is recommended that for normal use omp. site seats of concrete and wrought oak should be used, but that teak seats hould continue to be used where they are already in use.

# March Quarter 1961

#### Clearance of Undergrowth

The clearance of undergrowth and deformed trees has been completed in Hungershall Park, Tea Garden Lane and the approach to Rusthall Elms, and the work in Rusthall Road is well in hand.

#### Gravel Paths

The two paths leading from London Road at the rear of Messrs. Rawsons and Stevensons garages have now been "edged and regraded".

#### Lime Trees - Mount Edgcumbe

In accordance with the instructions of the Conservators these two Lime Trees have now been felled and two young Lime Trees have been planted in close proximity to the original positions.

#### Bishops Down Road

The Oak Tree on the edge of the Common adjacent to this road has been trimmed.

#### Rusthall Cricket Ground

The undergrowth has been cleared and thorn trees and other bushes have been trimmed on the North side of this cricket ground.

## Brighton Lake - Willows

The two Villow Trees referred to at the last meeting have now been received from the Parks Department and planted, one on each island in the lake.

#### Brighton Lake - Swans

The two swans temporarily placed on the lake from the Grosvenor Recreation Ground are still there and I understand from the Parks Superintendent that arrangements could probably be made with the Parks Committee for them to be retained. No difficulties have arisen during the time the swans have been on the lake and as far as can be foreseen none should arise should the Conservators decide to retain them.

The one doubt in my mind is the fact that from time to time the swans have left the lake and strayed across the Eridge Road and must, therefore, be some danger to passing traffic.

If it is decided to retain the swans I suggest that a temporary shelter of wattle hurdles be provided on the island at the Western and deeper end of the lake and that in due course this temporary shelter be replaced by a more permanent structure, probably of wood thatched with heather or other suitable material. The provision of this shelter and the care and maintenance of the swans can be met out of the Annual Estimates.

# Seats

The work of adjusting seets which have sunk or been displaced is well in hand. I recommend that the following new seats should be provided out of the special provision made for the next Financial Year to replace broken or missing seats revealed by the recent survey.

#### Clearance of Undergrowth

The clearance of undergrowth and defective trees has been completed along the North-Western side of Rusthall Road and has resulted in improved views of the Culverden area and affords glimpses of the Rocks in the Denny Bottom area.

#### Grass Cutting

Grass cutting commenced early in April and the areas in Bishops Down, Mount Ephraim, London Road, Hungershall Park and the Race Track have been completed.

#### Burnt Undergrowth

Burnt undergrowth resulting from fires has been cleared from a number of areas on both Commons.

# Seats

A number of the seats referred to in the recent survey have already been repaired and the new concrete ends for additional seats have been delivered and the seats will be fabricated and placed in position as soon as possible.

#### Tea Garden Lane

In accordance with the Conservators' authorisation the young oak saplings at the road-side in Tea Garden Lane have been cleared away.

#### Workmen engaged on The Commons

Following an upgrading of the pay of Street Sweepers, the workmen on the Commons, who were originally taken from this class of labour, became at a disadvantage relative to the Sweepers and the majority asked to return to sweeping. In order to avoid losing men now doing good work on the Commons it was decided, in consultation with the Borough Surveyor, to upgrade these men to the same group or classification. The effect was an increase in wages from 183/9 to 189/- per man per week and an estimated total increase for the year of about £50. The Conservators are asked to confirm this action. It is suggested that economies be effected to offset this increase in view of the increased amount granted by the Council for the current year.

#### Grass Cutting

All the usual areas have now been cut and prominent areas, like Mount Ephraim and London Road, have received a second cut. As a means of improving the standard of grass cutting, I recommend that consideration be given to including in the next Annual Estimates a sum of £100 for the purchase of a second grass cutting machine. A rotary Allen sickle is recommended as being suitable for use on banks and under damp conditions when the existing Allen scythe cannot be used. An improvement in the standard of grass cutting should result without any additional labour being required

#### Clearance of Undergrowth

Continuing the policy of clearing undergrowth and small defective trees alongside roads, it is suggested that parts of Londo Road (west side), Eridge Road (north-west side), Castle Road (southern end, both sides) and Rusthall Road (southern side) should be dealt with during the coming winter. I recommend that extensive "sucker" growth opposite Tweeddale Terrace in London Road and opposite the Pump Room in Eridge Road be cleared to show up the larger trees more clearly. In the case of Eridge Road, it should add to the safety of people using the steps leading to the Common opposite Linden Park Road.

#### Mount Ephraim Promenade

The surface tarring has been completed at a costof £73, showing a substantial saving on the amount of £120 provided in the Annual Estimates.

#### Happy Valley

With reference to Minute 8 of the Conservators Meeting on the 27th June last, I suggest that clearing be effected in two places at the top of Happy Valley in order to improve the view.

(a) From approximately the centre of the main open space and looking towards Rusthall Beacon, I suggest the removal of some dead and dyin Holly trees and relatively small and poorty shaped Oak trees.

(b) From the smaller open space southwards of the above and looking towards Ashdown Forest, I suggest the removal of small Oak trees under a fairly large Oak, and a clump of Holly and Oak trees at a lower level.

All the trees which it is suggested should be removed have been marked with white paint

#### Brighton Lake

Following the collapse of a portion of the surrounding wall,

The swans appear to have settled on this lake quite happily and are giving no trouble and it is recommended that the temporary shelter be replaced by a more permanent shelter constructed of larch poles, slab timber and heather thatched roof in accordance wi the sketch submitted.

# Oak Tree near Nevill Park

As a matter of urgency Mr. Theobald was engaged to fell and rea a moderate sized Oak tree which had been damaged during a gale and a potential danger to pedestrians on the Common.

## Seats

1) Three quotations were invited for the construction of the new se required and that of Messrs. Saxby and Everest was accepted. Unfor ly a delay has occurred in securing the necessary oak but delivery has been promised very shortly.

2) Mrs. C. Stone of 8 Bishops Down Road has offered to provide an additional seat to be placed on the south side of Langton Road opposite the one which she previously presented outside the Spa Hot subject to the Conservators accepting the offer.

3) The teak seat provided by Mrs. Morgan has been received and will shortly be placed in position.

The use of this open space for football appears to be on the increase and is probably attracting the youngsters away from Happy Valley. #### QUARTER ENDING MARCH 1962

#### Clearance of Undergrowth

In accordance with the approved programme, undergrowth has been cleared along the West side of Eridge Road from Linden Park Road to the Brighton Lake, and at the moment is proceeding in Castle Road and Major York's Road. The programme has been delayed due to labour being diverted to clearing up damage caused by the recent gales and also by fires on the Common.

#### Hungershall Park

A ditch and bank have been formed along the edge of the verge at two points where car parking was taking place on the Common. Apart from one or two instances the measures adopted appear to have been effective.

#### Mount Ephraim Road.

Secondhand kerbing has been laid along the edge of the Common and the bank made good behind the kerb where traffic had been encroaching on the edge of the Common.

#### <u>Seats</u>

Twelve additional seats are now ready for fixing in accordance with the list approved by the Conservators and these will be placed in position during April and it is recommended that a further 12 should be provided during 1962 to replace seats in the Mount Edgcombe, Major York's Road Nevill Park areas, where seats are missing and to replace seats that have already been smashed at Dingley Dell and Mount Ephrain.

#### Rotary Allen Sickle.

In accordance with provision made in the annual estimates for 1%2/63 quotations have been obtained for the above as follows:-

S.E. Haward & Co., £85.10.9d. H.R. Nash Ltd. £87.17.6d. Godfrey & Partners Ltd. £90.5.0d.

It is recommended that the machine should be purchased forthwith from Hawards and that a waterproof cover should also be purchased for the protection of this machine.

# Eridge Road Lime Trees South Eastern side

From an examination of the line trees along the edge of the Common between the Pump Room and Broadwater Park, serious defects have been found in 5 of these trees. It is recommended that 2 trees outside Nos.18 & 19 respectively should be felled immediately as being dangerous and that it would be advisable to also fell 2 additional trees, one outside No.17 and one outside No.16. A further tree inside the park enclosure of the Cornwallis Hotel has a hole in the trunk at ground level and should receive appropriate treatment to arrest the decay of the tree.

NOTE: It may be that this tree is under the control of the owner of the Hotel.

#### QUARTER ENDING JUNE 1962

## Clearance of Undergrowth

In accordance with the approved programme, undergrowth has been cleared along both sides of Castle Road, on the North Eastern side of Major York's Road and on the South Western side of London Road in the vicinity of Vale Royal. The entire area of Still Green has also been cleared, both of undergrowth and a considerable quantity of rubbish.

# Grass Cutting

Grass cutting commenced in April and at the moment is engaging all available labour. The area in Bishops Down, Mount Ephrain, London Road and Fonthill is now being cut for the third time using the new Allen Rotary Sickle, which has proved very satisfactory. In addition, the Lower Green Road area, Rusthall, the Lower Cricket Ground and areas on the North side of London Road, have also been cut.

#### Brighton Lake - Dead Swan

The following is the report of the Veterinary Surgeon on the Swan which died at the end of April:-

"Post morten examination of a female swan from Brighton Lake showed death due to peritonitis. A wad of coarse grass had managed to pass through the gizzard, and had become impacted in the small intestine. The pressure had caused the intestinal wall to rupture, and so caused the peritonitis. I broke down the grass, but there was no fish hook inside it."

#### Peter M. Sutton. M.R.C.V.S.

Enquiries have been made concerning the provision of another female swan through the Queen's Swan Master and delivery of the swan has been promised very shortly.

The Conservators are asked to approve the action taken to secure another swan. It is probable that the sole cost to the Conservators will be that of catching and delivering the swan.

#### Eridge Road Line Trees.

The four seriously defective line trees near Nos. 16 to 19 Eridge Road have now been felled and grubbed and proved to be very rotten at the centre. The owners of the Cornwallis Hotel have undertaken to treat the hole in the trunk of the line tree standing in their parking enclosure.

## Bishops Down - Litter Basket

The additional litter basket approved by the Conservators, has now been fixed near the seats in the "South of France".

#### Brighton Lake - Replacement Swan

A young female swan was received from the Queen's Swan Master during July and soon settled down.

The actual charge made was for catching and delivering the swan and amounted to £5.16.11d.

#### Litter Baskets

In accordance with Min.8 - 26th June 1962, a new litter basket has been fixed at the entrance to the Fair Ground off Major York's Road.

With regard to sites for the six additional litter baskets to be provided in next year's estimates, the following are suggested:-

(a) Brighton Lake;
 (b) Fonthill;
 (c) footpath - Church Road to Molyneux Park;
 (d) Rusthall Cricket Ground;
 (e) Toad Rock, Harmony Street.

#### Eridge Road - Replacement of Line Trees.

With reference to the decision to consider another type of tree as replacements for the lime trees on the South Eastern side of Eridge Road, I suggest that one of the following would be suitable:-

1. Maple, choosing a variety with attractive foliage.

2. Acacia, on account of its attractive foliage at all seasons.

3. Silver Birch, because of its attractive foliage and trunk.

I recommend them for consideration in that order as I think the Maple is most suitable because of its moderate height, 35 to 40 feet, its attractive foliage, and because it would be in harmony with the types of trees occurring naturally on the Commons.

In filling the gaps in this row of trees, I suggest that a more open spacing be adopted than is the case at present and that the trees be sited to avoid, as far as possible, obstruction to the houses and to garage entrances.

#### Lower Cricket Ground.

The existing rails at the North Eastern and South Western ends are now very unattractive in appearance. The rails are rusty and many of them are bent and the posts are uneven and some of the wooden ones are defective. I suggest that consideration should be given to including an amount in next year's estimates for renewing the rails in the same manner **as for** the Higher Cricket Ground some years ago, and at the same time to resetting the posts and replacing those which are defective with concrete posts.

#### Grass Cutting.

Grass cutting has continued in the normal areas along Mount Ephrain, London Road, Eridge Road and at Rusthall. Also the area in Bulls Hollow, Apsley Street and Upper Street, Rusthall have been cut.
